



## The Timing and Location of the Open, Women's and Seniors' Playoffs

The ABF Tournament Committee is seeking feedback on the timing and location of the open, women's and seniors' playoffs from players who have contested past playoffs or are aiming to contest future playoffs.

The ABF's current arrangements for playoffs came into effect in 2016. The ABF indicated at that time that it would seek player feedback on the format, timing and related issues as the four-year cycle drew to a close. A detailed consultation will take place in 2019 so that changes – if any – can be introduced with adequate notice.

In advance of that detailed consultation the ABF seeks players' views on two issues:

1. Should some adjustments be made to the November/December time slot for the playoffs?  
(Please note that players will be consulted next year about whether the playoffs should revert to February/March or some other time slot.)
2. Should the playoffs be held in Canberra?

### Timing

The current practice is for:

- the open playoffs to start two weeks after the Spring Nationals, i.e. the second weekend of November; and

- the women's and seniors' playoffs to start the weekend after the GNOT final, i.e. the first or second weekend in December.

The timing was chosen so players could have a break between events (e.g. the Spring Nationals and the Open Playoffs), and to allow players who were unsuccessful in the Open Playoffs time to put together teams for the Women's or Seniors' Playoffs and meet requirements such as notification of systems.

This year that means the women's and seniors' playoffs will start on 8 December and finish on 13 December.

### Location

In 2016 and 2017 the playoffs were held in Canberra. For the previous 14 years all the playoffs except one were held in Sydney.

The playoffs were moved from Sydney because of the difficulty and significant cost of finding a suitable venue, especially in December when hotels are expecting to host Christmas functions (which are a significant source of revenue for hotels).

In addition to venue costs, holding the playoffs outside Canberra increases costs for the ABF as all the equipment (screens, boards, Bridgemates, bidding boxes, BBO computers and cameras etc) has to be shipped. Depending on the location, these costs may be partially offset by a reduction in the subsidies paid to players to travel to the venue.

A number of players have in the past expressed a preference for holding the trials in a location that is different from where they live. Their argument has been that this avoids lengthy travel times and the distractions of home.
