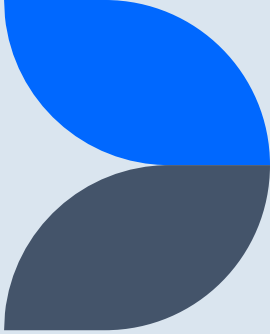

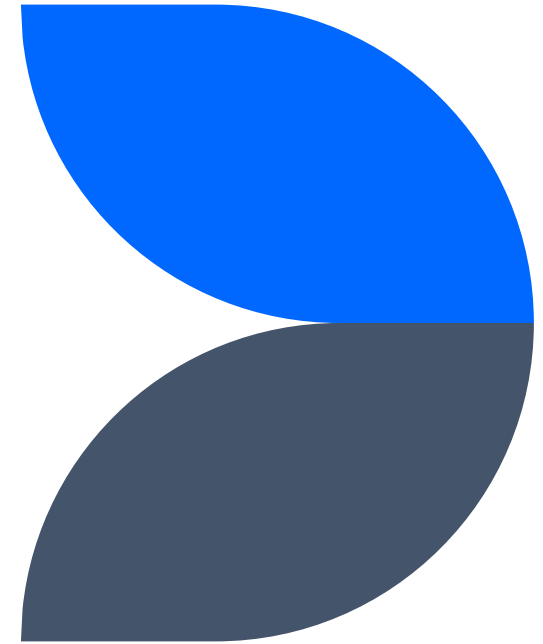

# Approach

- The Online Committee started with discussion of scope and then worked on discovery
- Two face-to-face discussions at national events were held and surveys were sent to clubs and players to obtain feedback (155 club responses, 2,490 player responses)
- Discussions and investigations were undertaken more broadly, especially with New Zealand (Kate Terry)
- Volunteers were enlisted onto our working groups
- Reports from working groups were obtained and consolidated

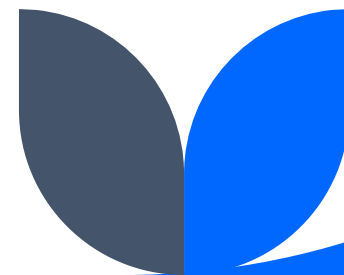

# Findings - Teaching

- The ABF should manage a page with up-to-date links to good teaching resources and online lessons
- The ABF Education page should be enhanced and publicized
- The ABF to provide supporting materials which assist beginners who have been introduced to the game online to join a F2F club





# Findings - Etiquette

- The ABF to provide **guidelines, codes of conduct** and **regulations** specifically for online bridge
- The ABF to approve recognised platforms for online bridge
- Proven statistical analysis tools to be used to detect cheating
- The ABF to develop training materials for online directors



# Findings – Assisting Clubs

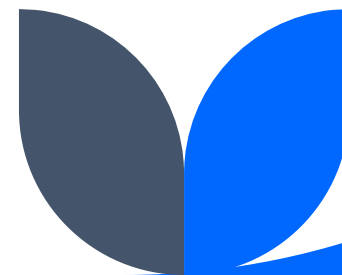
- There are three types of clubs to consider:
  - Clubs able to manage online bridge by themselves
  - Clubs needing ABF support to run online bridge
  - Clubs needing to work together to run online bridge
- A central repository of resources should be provided by the ABF
- MyABF should be used to provide:
  - Registration and marketing
  - Payments and Reporting
  - Registry of directors
  - Player Blacklisting

# Findings – Tournaments

- The ABF should appoint an Online Manager to assist at all levels
- The ABF should ensure it is not seen to be competing with clubs
- The ABF should support new session types such as speed bridge, combination events and shorter session times
- For ABF events, online innovation should be considered to reduce cost. Online events could be run in parallel for example at the GNOT and ANC
- Online bridge must not be considered inferior to face-to-face bridge for serious bridge competitions
- Gold points only awarded when playing with video and audio
- There should be no difference between masterpoints awarded online or face-to-face

# Strategy – Looking at the future of Bridge

- The strategy working party produced a very interesting paper which went far beyond the remit of the Online Committee
- We believe this should be considered separately as many of the recommendations are far reaching
